Explanation of significant increases in the budget (explanation required if Proposed Percentage Change is greater than 5%):

Expenditures are up 8.3% from last year or about \$165,000. The largest percentage increases come from the sheriff, recycling, NIACOG dues, libraries, and secondary roads. Much of the secondary roads increase is due to cuts from last year. The remainder of the increase would be to provide adequate reserve funds.

The above tax rates do not include county voted levies, mental health and disabilities services levy, debt service levy and the rates of other local jurisdictions.

Regarding proposed maximum dollars, the Board of Supervisors cannot adopt a higher tax asking for these levies following the public hearing.

Budget year effective property tax rate is the rate that would be assessed for these levies if the dollars requested is not changed in the coming year.
